Stockholm University Department of Culture and Aesthetics Theatre Studies Performativity: Gender and Body on Stage (TVPERF, Spring 2020, MA-level, 7.5 ECTS)

The course will be taught online and we will use the Zoom e-meeting service for lectures and seminars. The course also has an Athena site, which is an online platform that contains relevant information, official documents, important links and selected course literature (<u>https://athena.itslearning.com</u>).

Course content

The course provides an in-depth knowledge of gender and queer theoretical concepts from an interdisciplinary perspective. It covers various theoretical lines of argumentation regarding identity and sexuality. It targets students from a variety of disciplines, especially those who need a theoretical refinement for their master's thesis. The course illustrates how theories of gender, sexuality and power can be relevant for different performative and theatrical events.



Expected learning outcomes

Having completed this course, students are expected to have the skills to:

- demonstrate a nuanced understanding of the formulation of theories of performativity in a specific social and historical context;

demonstrate a good understanding of the links between performativity, gender and queer studies, and feminism and be able to relate these to their respective disciplines in the humanities and/or social sciences;
work independently with theoretical texts, present these for the seminar group and stimulate a critical

discussion and argumentation;

- in an independent way be able to apply the theories covered by the course on a specific material and engage in a longer reflection in both speech and writing.

Attendance and learning environment

Attendance is mandatory. A student may miss one class, but any additional absence needs to be compensated with a 3-page written essay that critically discusses the literature assigned for that session. If a student has missed three or more classes, a final grade cannot be assigned. In order to guarantee a safe learning environment that stimulates critical thinking, students are expected to respect different and divergent opinions and political/cultural/religious points of view and to express disagreement in a calm and civil way that does not blame or shame other members of the class. Remember to actively listen to an argument, critically examine it and articulate your own position as succinctly and as convincingly as possible. Students are encouraged to relate and apply the various theoretical concepts to their own fields of interest and/or practice; however, at no point are they required to disclose any personal or confidential information in either group discussions or written assignments.

Course requirements

Evaluation consists of a written essay, in which students are required to critically explore the relationship between performativity and performance. Students formulate their own research question and decide which of the theoretical concepts outlined during the course they wish to discuss and apply onto an independently chosen case study. Consistent references to and a critical engagement with the course literature are compulsory. The assignment needs to be submitted as an email attachment (.doc, .docx or .pdf only) <u>no later than Friday 29 May at 5 PM</u>. Format: 5-6 pages, Times New Roman or equivalent (excl. foot/endnotes, works cited, illustrations etc.); size 12; space 1.5.

Students are expected to have prepared all of the assigned readings assigned for each session and to actively participate in the seminars. They are expected to take notes while preparing the readings and bring at least one considered thought, pertinent question or relevant example for possible discussion to each seminar. In order to critically engage with an article or book chapter, please think of the following:

- identify and succinctly articulate the major research questions and critically reflect on the credibility and validity of the author's arguments, sources and conclusions;
- situate the text in relation to the course literature and content studied up until that point;
- think of a relevant example of a performance that can illustrate the issues at stake;
- pick a relevant quote and prepare a pertinent question to stimulate a critical discussion with the other class members.

Evaluation criteria

A The written essay has been fulfilled in a timely manner, reveal an excellent understanding of the field of Performativity and its relationship to and impact on Theatre and Performance Studies, offers proof of highly advanced critical thinking skills and displays an impressive degree of intellectual independence and creativity. The student demonstrates an excellent ability to articulate and critically reflect upon key theoretical and methodological concerns in Queer Theory, Performance and Performativity that also problematizes their own positionality. Language and style are at an appropriate academic level.

B The written essay has been fulfilled in a timely manner, reveals a very good understanding of the field of Performativity and its relationship to and impact on Theatre and Performance Studies, offers proof of advanced critical thinking skills and display a high degree of intellectual independence and creativity. The student demonstrates a very good ability to articulate and critically reflect upon key theoretical and methodological concerns in Queer Theory, Performance and Performativity that also problematizes their own positionality. Language and style are very good.

C The written essay reveals a good understanding of the field of Performativity and its relationship to and impact on Theatre and Performance Studies, offers proof of critical thinking skills and display signs of intellectual independence and creativity. The student demonstrates a good ability to articulate and reflect upon key theoretical and methodological concerns in Queer Theory, Performance and Performativity that also attempts to problematize their own positionality.

D The written essay reveals a satisfactory understanding of the field of Performativity and its relationship to and impact on Theatre and Performance Studies. The student demonstrates an adequate ability to articulate key theoretical and methodological concerns in Queer Theory, Performance and Performativity.

E The written essay reveals a very basic understanding of the field of Performativity and its relationship to and impact on Theatre and Performance Studies. The student demonstrates an elementary ability to articulate some theoretical and methodological concerns in Queer Theory, Performance and Performativity.

Fx The criteria under E were not fully met and some additional work is required to reach a passing grade.

F The student failed to meet the criteria under E.

Late submissions will be accepted in the last week of August; in that case, the final grade can be no higher than a C.
